INTRODUCTION

The main text part of a project **must start on a new page** with the title "INTRODUCTION".

The introduction must contain sufficient basic information to enable the reader to understand and evaluate the project. If there are previous studies to be mentioned on the subject, these are also given in the introduction section. When conducting a literature review, it is important that citations from previous technical and scientific studies are of informative quality and quantity.

1. LITERATURE REVIEW or GENERAL INFORMATION

Literature Review section provides information about the study in the literature, mentions previous studies related to the project presents general information about the subject, gives the reasons for the need for the project, defines the problem, and states the purpose of the study clearly.

1.1. Typeface

For project writing, 12-point "Times New Roman" font must be used and the text should be black. The text in tables and figures can be reduced to 8 points, if necessary. The headings of tables and figures, as well as the references under the tables and figures, must be in 10 points. The text must be written in upright normal letters. Bold letters are used in headings. Italic font can be used only when necessary (Latin names, abbreviations, definitions, etc.). One character space should be left after all punctuation marks such as commas and periods.

1.2. Headings and Spellings

• Primary Sub-Heading

Primary sub-headings must be bold. The first letters of the words of the heading must be uppercase. Example: **2.1. Traditional Finance Theories**

• Secondary Heading: Initials must be in uppercase

Example: 2.1. Expected Utility Theory

• Secondary Sub-Heading

Secondary sub-headings must be bold. The first letters of the words of the heading must be in uppercase and the others in lowercase.

Example: 2.1.1 Expected Utility Theory

• Tertiary heading: The first letter must be in uppercase, others in lowercase.

Example: 2.1.1 Expected utility theory

• Tertiary Sub-Heading

Tertiary sub-headings must be bold and the first letter of the words of the heading must be in uppercase and the others in lowercase.

Example: 2.1.1.1. Weak efficient market theory

1.3. Tables and Figures

All tables and figures in the project must be cited in the text. Tables and figures taken from other sources must be cited after the title of the table or figure.

More than one table or figure can be placed on the same page. If necessary, tables or figures can be given in the Appendices.

Tables and figures must be numbered in the form of "Table 1.2." and "Figure 1.1." with the first number being the chapter number and the second number being the sequence number of the table or figure within the chapter. A space must be left after the last full stop. The number and description of each figure must be written under the figure, and the number and description of each chart must be written above the table. Figure name, table name or description must be centered.

The table caption must be written using one-line spacing. There must be 12

spaces before and 6 spaces after the text. The caption and the entire table must be on the same page. For tables larger than one page, the same table number and caption must be written at the beginning of the second page, and (continued) must be written in parentheses between the table number and caption.

The first paragraph in the text section following the table must be written with 12 spaces from the top and 6 spaces from the bottom. The headings that follow the tables should be used exactly as they are without any change in the abovementioned heading formats.

There must be a space of 6 between the figure and the figure caption and 12 after it. The figure's name is written with one space. The figure's caption and the entire figure should be on the same page. For figures larger than one page, the same figure number and caption should be written at the end of the figure on page 2, and (continued) should be written in parentheses between the figure number and caption.

Figures should be formatted to be in line with the text. The last paragraph in the text section preceding the figure should be written with 6 spaces at the top and 12 spaces at the bottom. If necessary, footnotes used for tables should be written with 1 line spacing and 10 pt. font size.

1.6. Footnotes

Footnotes must be numbered in round brackets on the page where they appear in the text and separated from the main text with a line drawn at the end of the page. The font size of footnotes must be 10 pt.

1.7. Line Spacing and Layout

The term "spacing" in the guidelines refers to the distance between lines of text, which is approximately equivalent to the size of two small letters. The project text is written with 1.5 spacing opposing margins. Table of Contents, Abstract, References, Abbreviations and Appendices, names and descriptions of figures and tables in the text and footnotes must be written with one-line spacing.

Paragraph indentation starts from 1.25 cm inside and there must be no empty spaces between paragraphs. In the project text, syllable separation in words should not be done with hyphens.

Primary headings start on a new page and 72-point margins are left before the heading and 18-point margins are left after it. Second-level headings are preceded by an 18-point space and a 12-point space after; tertiary and quaternary headings are preceded by a 12-point space and a 6-point space after. Headings lower than the fourth level cannot be used. There must be written text under each heading.

Headings cannot be written as the last line of the page. If there is no space available for two lines of text after the heading, the heading is placed on the next page. The first line of a paragraph cannot be written as the last line of the page and the last line of a paragraph cannot be written as the first line of the page.

1.8. Page Numbering

All pages of the project except the outer and inner covers must be numbered.

Starting from the table of contents, the preliminary pages such as the list of abbreviations, tables, figures and abstracts, if any, are numbered with Roman numerals (I, II, III...), and the text section starting with the introduction is numbered with Arabic numerals (1, 2, 3...).

Page numbers are written 1.5 cm above the bottom edge of the paper and in the center of the writing frame without using parentheses, lines, etc. Page numbers must be written in Times New Roman and the font size must be 12 pt.

BIBLIOGRAPHY is listed from **A** to **Z** in order of the last name of the authors. This section is written with 1 line spacing.
